Social Detox - 230 women were admitted to our Social Detox Program in 2017. This was
a 13% increase from our 2016 admissions. Volunteer Program Coordinators donated 5,828
hours to our Social Detox Program, and 84% of those volunteer hours were alumnae of
our 14-day Program. In 2017, 80% of women who were admitted successfully completed
this program.

Peer Recovery - In 2017, we had over 19,000 visits to our Peer Recovery Program
meetings, classes, and workshops. These were facilitated by 129 volunteers who
donated 1,115 hours to this program. Additionally, 72 women volunteered as sponsors
to women in our Social Detox Program, donating 497 hours of their time.
